Republican presidential nominee Donald Trump has said that in-vitro fertilisation (IVF) treatments will be paid for by insurance companies or the government if he returns to the White House. "I was always for IVF. Right from the

beginning, as soon as we heard about it," he told NBC News on Thursday.

The new campaign pledge comes after his Democratic rival, Vice-President Kamala Harris, and other members of her party have alleged that Republican-led abortion restrictions in some states could further threaten access to fertility treatments. Trump's announcement could put him at odds with some conservative anti-abortion activists who want to ban IVF for discarding unused human embryos.

But he committed to the new position on Thursday in the interview with NBC. "Under the Trump administration, we are going to be paying for that treatment," Trump told the news outlet. "Or we're going to be mandating that the insurance company pay." IVF treatments can be very expensive - often around \$20,000 (£15,000) per round - and are rarely covered by insurance in the US. Trump did not explain how this new policy would work or be put into effect.

The Harris-Walz campaign was quick to respond Trump's new policy position, blaming him for the US Supreme Court's decision to overturn the landmark 1973 abortion case - Roe v Wade - which
