During the quarter members of the company passed a special resolution through postal ballot on 26th July, 2023 by way of remote e-voting in accordance with the provisions of Section 108 & 110 of the Companies Act 2013 to approve sub-division/split of every 1 (one) equity share of face value of Rs. 10/- (Rupees ten only) each into 5 (five) equity shares of the face value of Rs. 2/- (Rupees two only) each. The number of shares stand increased from 15245000 to 76225000 due to aforesaid split of equity shares.
